Use a socket wrench and 13mm socket to secure the Bumper End Caps to the Bumper with six (6) M8-1.25x25 Button Head Socket Screws #413.69, six (6) M8 Nylon Lock Nuts #470.06, and six (6) M8 Flat Washers #484.93 per End Cap.

NOTE: The Screws and Washers go on the outside of the End Caps, and the Lock Nuts go on the inside of the Bumper.
